THE EASTBOURNE BOROUGH COUNCIL (TEMPORARY STREET CLOSURE) (NO. 20) ORDER 2018

TOWN POLICE CLAUSES ACT 1847 (AS AMENDED)

AIRBOURNE THE 2018 EASTBOURNE INTERNATIONAL AIRSHOW

Eastbourne Borough Council in exercise of their powers under Section 21 of the Town Police Clauses Act 1847, as amended by Section 28 of the East Sussex Act 1981 and all other enabling powers, and after consultation with, or with the consent of, as may be required by statute, the County Council of East Sussex and the Chief Officer of Police, hereby make the following Order:

1. For the purposes of facilitating the holding of **AIRBOURNE THE 2018 EASTBOURNE INTERNATIONAL AIRSHOW** in Eastbourne, the lengths of roads set out in the Schedule to this Order shall be closed to vehicular traffic between the hours of 7.00 a.m. on Wednesday 15th August and 1.00 p.m. on Monday 20th August 2018
2. Nothing in this Order shall prevent a Police Officer from suspending for any period the provisions of this Order in respect of any highway closed by virtue of this Order or prohibit any act done at the discretion or with the consent of a Police Officer.
3. Should the event be cancelled then the provisions of this Order shall not take effect.
4. The making of this Order does not authorise or otherwise make lawful the obstruction of the highway nor shall it be interpreted as giving such authorisation.
5. This Order may be cited as "The Eastbourne Borough Council (Temporary Street Closure) (No. 20) Order 2018".
6. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament, as if this Order were an Act of Parliament.

CAVENDISH PLACE from its junction with Marine Parade to its junction with Seaside Road for the access and egress of the Park and Bus service from 7.00 a.m. on Thursday, 16th August, 2018 until 11.00 p.m. on Sunday, 19th August, 2018.

DEVONSHIRE PLACE from its junction with Grand Parade to its junction with Compton Street to provide parking for registered disabled drivers from 7.00 a.m. on Thursday, 16th August, 2018 until 7.00 p.m. on Sunday, 19th August, 2018.

KING EDWARD'S PARADE from its junction with Lascelles Terrace or Carlisle Road to its junction with Silverdale Road from 7.00 a.m. on Wednesday, 15th August, 2018 until 1.00 p.m. on Monday, 20th August, 2018.

JEVINGTON GARDENS from its junction with King Edward's Parade to its junction with Compton Street .Access only no access to seafront from 7.00 a.m. on Wednesday, 15th August, 2018 until 1.00 p.m. on Monday, 20th August, 2018.

WILMINGTON SQUARE (both sides) from its junction with King Edward's Parade to its junction with Compton Street from 7.00 a.m. on Wednesday, 15th August, 2018 until 1.00 p.m. on Monday, 20th August, 2018.

BEACHY HEAD ROAD from its junction with Beachy Head Road (B2103) to its junction with East Dean Road between 4.00 p.m. and 6.00 p.m. daily from Thursday, 16th August, 2018 until Sunday, 19th August, 2018.

KING EDWARD'S PARADE from its junction with Carlisle Road to its junction with Devonshire Place (West) to allow for the safe access and egress of visitors to the evening stage events and fireworks display between 7.00 p.m. and 11.00 p.m. on Sunday, 19th August, 2018.

LASCELLES TERRACE from its junction with Grand Parade to its junction with Compton Street to provide an evacuation route for visitors to the evening screen/fireworks display between 7.00 p.m. and 11.00 p.m. on Sunday, 19th August, 2018.

HOWARD SQUARE from its junction with Grand Parade to its junction with Compton Street to provide an evacuation route for visitors to the evening screen/ fireworks display between 7.00 p.m. and 11.00 p.m. on Sunday, 19th August, 2018.

BURLINGTON PLACE from its junction with Grand Parade to its junction with Compton Street to provide an evacuation route for visitors to the evening stage events and fireworks display between 7.00 p.m. and 11.00 p.m. on Sunday, 19th August, 2018.
