VARIOUS ROADS, SANDWICH

(TRAFFIC RESTRICTIONS)

TEMPORARY ORDER 2011

For the safety of the public and to maintain a free flow of traffic during the Open Golf Championship 2011, Kent County Council has made an Order restricting traffic on Various Roads, Sandwich.

This Order takes effect on or after 12 July 2011, remains in force until 18 July 2011 and will cease to have effect on completion of the Open Golf Championship.

The roads affected and nature of restrictions are as described below.

DEAL ROAD, SANDWICH (shown on some maps as Dover Road)

All northbound traffic except permit holders will be prohibited, from the junction with Dover Road.

NEW STREET, SANDWICH

No Right Turn southbound from New Street into St Bart's Road, except buses & HGVs.

DELFSIDE, SANDWICH

Road closed to traffic at the junction with St Georges Road. (Access for residents only)

DOVER ROAD, SANDWICH

All traffic prohibited, except emergency vehicles, at the roundabout junction with the A256 and A258 - 'Water Gardens' Roundabout.

GALLIARD STREET, SANDWICH

No Entry *southbound* from Galliard Street into New Street, except buses, from 6.00 am until 10.00 pm.

HIGH STREET, SANDWICH

Road closed between Strand Street and the Toll Bridge.
No Left Turn from High Street towards Ramsgate Road at the junction with The Quay from 6.00 am until 2.00 pm.
Access to and from The Quay will be maintained.

MONKS WAY, SANDWICH

No Entry Sandwich-bound except buses and HGVs, from the exit of the second roundabout (by Pfizer's car park).

ST BART'S ROAD, SANDWICH

No Right Turn from St Bart's Road into Deal Road, except buses & HGVs, from 6.00 am until 10.00 pm.

ST GEORGE'S ROAD, SANDWICH

No Right Turn from St George's Road into New Street, except buses & HGVs, between 6.00 am and 2.00 pm.

~ The following roads will become One Way only with the direction of traffic flowing towards the event in the morning and away from the event in the afternoons, known as 'Tidal Flow' ~

RAMSGATE ROAD, SANDWICH

All southbound traffic prohibited except permit holders, from the junction with Willowbank.

Will become one way only between the junctions with Willowbank and High Street
6.00 am to 2.00 pm - southbound only
2.00 pm to 10.00 pm - northbound only

KNIGHTRIDER STREET, SANDWICH

Will become One Way only between the junctions with The Quay and Sandown Road
6.00 am to 2.00 pm - southbound only
2.00 pm to 10.00 pm - northbound only

SANDOWN ROAD, SANDWICH

Will become One Way only between the junctions with Knightrider Street and St George's Road
6.00 am to 2.00 pm - eastbound only
2.00 pm to 10.00 pm - westbound only

No Entry westbound on Sandown Road from a point immediately west of the junction with St George's Road from 6.00 am until 2.00 pm.

Afternoon only - No Entry from the junction with the western exit of the Green Car Park eastbound from 2.00 pm until 10.00 pm

The junction with Manwood Road will be closed, with access to Manwood Road maintained from St George's Road.

UPPER STRAND STREET, SANDWICH

Will become One Way only between the junctions with High Street and Knight rider Street

6.00 am to 2.00 pm - eastbound only

2.00 pm to 10.00 pm - westbound only

VARIOUS ROADS, DEAL

(TRAFFIC RESTRICTIONS) TEMPORARY ORDER 2011

For the safety of the public and to maintain a free flow of traffic during the Open Golf Championship 2011, Kent County Council has made an Order restricting traffic on Various Roads, Deal.

This Order takes effect on or after 12 July 2011, remains in force until 18 July 2011 and will cease to have effect on completion of the Open Golf Championship.

The roads affected and nature of the restrictions are as described below.

ETHELBERT ROAD, DEAL

Will be closed at junction with Golf Road. Residents advised to use Sandown Road for access.

GOLF ROAD, DEAL

All northbound traffic prohibited except permit holders, from the junction with Ethelbert Road.

Road closed immediately to the South of the junction with Godwyn Road.

The junction with Redhouse Wall will be closed. Residents of Redhouse Wall can access their properties via Royal Cinque Ports Visitor Car Park

GOLF ROAD, DEAL / GUILFORD ROAD, SHOLDEN / ANCIENT HIGHWAY, WORTH

These roads will become One Way only, from a point immediately north of 138 Golf Road, including the entire length of Guilford Road and Ancient Highway to the junction with Waldershare Avenue

6.00am to 2.00pm - northbound only

2.00pm to 10.00pm - southbound only.

Cyclists and horse riders will be prohibited between 6.00 am and 10.00 pm on the sections of these roads described in the preceding paragraph

For the safety of the public and to maintain a free flow of traffic during the Open Golf Championship 2011, Kent County Council has made an Order restricting traffic on Various Roads, Sandwich.

This Order takes effect on or after 12 July 2011, remains in force until 18 July 2011 and will cease to have effect on completion of the Open Golf Championship.

The roads affected and nature of restrictions are as described below.

VENSON ROAD, EASTRY - will be closed at the junction with the northbound carriageway of the A256 Dover Road.

The alternative routes are

Westbound via A256, Dover Road, Eastry and Pike Road

Eastbound via Pike Road and Dover Road, Eastry

DOVER ROAD, TILMANSTONE - will be closed at the exit from the northbound carriageway of the A256 into Dover Road.

Residents advised to access Dover Road at its junction with Barville Road.

KENNEL HILL, TILMANSTONE - the exit from Kennel Hill onto the northbound carriageway of the A256 closed between 6.00 am and 11.00 am. Residents advised to use Sandwich Road as diversion.

BARVILLE ROAD - No Right Turn from Barville Road eastbound into the temporary Park and Ride site

A256 DOVER ROAD & WHITFIELD BY-PASS, DOVER AREA

(50 MPH SPEED LIMIT)

TEMPORARY ORDER 2011

For the safety of the public and to maintain a free flow of traffic during the Open Golf Championship 2011, Kent County Council has made an Order to impose a temporary mandatory speed limit of 50 mph on the A256 Dover Road and Whitfield By-pass, Sutton, Tilmanstone and Eastry, as described below.

On the northbound carriageway, from the junction with Sandwich Road, Whitfield to Eastry Roundabout

On the southbound carriageway, from the junction with Eastry Roundabout to the roundabout junction with Boys Hill / Barville Road

This Order takes effect on or after 12 July 2011, remains in force until 18 July 2011 and will cease to have effect on completion of the Open Golf Championship.

(PARKING & WAITING RESTRICTIONS)

TEMPORARY ORDER 2011

For the safety of the public and to maintain a free flow of traffic during the Open Golf Championship 2011, Kent County Council has made an Order to add, suspend or amend existing waiting restrictions, loading restrictions and on-street parking in certain streets in Deal and Sandwich.

This Order takes effect on or after 12 July 2011, remains in force until 18 July 2011 and will cease to have effect on completion of the Open Golf Championship.

There will be no waiting at any time and no loading or unloading between 7.00 am and 11.00 am and between 4.00 pm and 8.00 pm (except where otherwise stated) on the sections of roads shown below, as follows.

SANDWICH

DEAL ROAD – for its entire length - except Taxis when signs are on site identifying the exclusion zone.

ST GEORGE'S ROAD – for its entire length

ST GEORGE'S LEES – for its entire length

DELFSIDE – for its entire length

SANDOWN ROAD – for its entire length, with the exception of any bays with no signage

GUILFORD ROAD – for its entire length

KNIGHTRIDER STREET – from the junction with The Quay to the junction with Sandown Road

THE QUAY – for its entire length, with the exception of any bays with no signage

UPPER STRAND STREET – for its entire length

RAMSGATE ROAD – from its junction with the A256 to its junction with The Quay

MONKS WAY – for its entire length

STRAND STREET – for its entire length, with the exception of any bays with no signage

ASH ROAD – for its entire length

ST BART'S ROAD – from the junction with New Street to the eastern-most boundary of property no. 127

NEW STREET - from the junction with Deal Road to the junction with Galliard Street
No Waiting at any time and No Loading/Unloading (except buses) – between 6.00 am and 10.00 pm

East Side – from its junction with Godwyn Road to its junction with Albion Road

West Side – from its junction with Godwyn Road to its junction with Harold Road

GODWYN ROAD

South Side – for its entire length

North Side – from the junction with Golf Road for a distance of 20 metres eastbound

North Side – from the junction with The Marina for a distance of 20 metres westbound

GOLF ROAD – from the junction with Godwyn Road to its northernmost point

GUILFORD ROAD, SHOLDEN – for its entire length

ANCIENT HIGHWAY, WORTH – for its entire length

GUILFORD ROAD, WORTH – for its entire length

(TEMPORARY CLOSURE)

TEMPORARY ORDER 2011

For the safety of the public during the Open Golf Championship 2011, Kent County Council has made an Order prohibiting the use of those sections of Various Footpaths at Worth which fall within the boundary of Royal St George's Golf Links, as shown below.

EE249 - Public Footpath between Princes Drive and Guilford Road.

EE231 - Public Footpath (part of the Saxon Shore Way) between Princes Drive to North Stream.

The alternative route is via EE230 - Public Footpath between Princes Drive and North Stream.

This Order takes effect from 10 July 2011 until 18 July 2011 inclusive, and ceases to have effect on completion of the Open Golf Championship.
